

ALLEN EARNS TITLE SHOT AFTER DOMINANT VICTORY

EFC 129 Results

Johannesburg, South Africa - EFC 129 delivered a spectacular night of mixed martial arts action at the World Sports Betting Arena, where former featherweight champion Boyd Allen marked his return to the Hex in emphatic fashion.

Allen stopped Vince Bembe in the very first round of their featherweight contender bout, reminding fans why he is regarded as one of the most technically gifted fighters in EFC history. Using trademark composure and precision, Allen controlled the exchanges before finishing Bembe with strikes at 4:18 of Round 1.

With the victory, Allen secures his position as the next challenger for Billy Oosthuizen's EFC Featherweight Championship, setting up a massive title clash for 2026.

The co-main event saw Steven Goncalves deliver a flawless performance, submitting Guide Moyo in the opening round via rear naked choke. Heavyweight standout Terrence Born made a statement of his own, needing only 38 seconds to stop Sholto Luiters in a devastating display of power.

Elsewhere on the main card, Cole Henning earned a dominant unanimous decision over Christopher Matukane, and Moses Mokhari impressed with a slick first-round submission victory over Sibusiso Sovendle.

Prelims featured several thrilling performances, including unanimous decision wins for Nerik Simoes, Dauda Rajabu, and Bruce Mayasi, along with strong stoppage victories for Godfrey Mkhwanazi and Mfanafuthi Ngobese.
